Identity Information	Your name, surname, Turkish ID number / passport number / foreign identification number, date of birth
Contact Information	Your address, e-mail address, telephone number
Legal Transaction Information	Information contained in correspondence with judicial authorities and court file information
Physical Premises Security Information	Your entry and exit records to/from our Institution, CCTV recordings
Transaction Security Information	Your internet access records, IP address, user transaction logs, log records, system and network usage information
Audio and Visual Records	Your audio and visual recordings
Vehicle Information	Your vehicle license plate number, vehicle brand and model information, vehicle entry and exit time information, valet and parking usage information
Request and Complaint Information	Information regarding your requests, suggestions and complaints, and related application and evaluation records created in this scope

3. Processed Personal Data, Purposes of Processing and Legal Grounds

Your personal data collected may be processed for the purposes (“**Purposes**”) and based on the legal grounds set out below, in accordance with Article 5 of the Law.

5. Method of Collection of Your Personal Data

Your personal data are collected by our Institution for the purpose of ensuring security through electronic means such as closed-circuit camera recording systems and vehicle recognition systems, and through visitor registration procedures conducted physically within our Institution's campuses and facilities.

6. Your Rights as a Data Subject Under Article 11 of the Law

As a data subject, you may submit your requests regarding your personal data processed by us under Article 11 of the Law, in accordance with the Communiqué on the Principles and Procedures for Application to the Data Controller. Your requests may be submitted at any time in writing, or via registered electronic mail (KEP), secure electronic signature, mobile signature, or using the e-mail address you have previously notified to us and which is registered in our systems.
